Who is conducting the promotion?

Entry

Harness Racing NSW reserves the right, in its discretion, to declare any Number 1 Club Carnival of Cups Competition form on which all of those details are not provided ineligible to participate in the promotion.

9. Harness Racing NSW is entitled to rely on:

- (a) the accuracy of information provided in any Number 1 Club Carnival of Cups Competition form; and
- (b) the submission of a Number 1 Club Carnival of Cups Competition form in the manner provided for in paragraph 6 as conclusive evidence that the person named on that form entered the relevant venue and date listed in clause 5.

What are the prizes

10. There will be a total of one (1) prize. No warranties are provided by Harness Racing NSW in respect of the prize.

11. The prize includes a 2011 Toyota Yaris, five door hatchback, manual. Prize is non transferable.
