I/we give authority for my/our horse to be entered in and accepted for claiming races to be conducted under the Rules of Harness Racing, and I/we hereby authorise my/our trainer, being the person whose name appears above and whom has lodged a current stable return in respect to the above horse, to enter the horse for this type of race.

I/we declare that the horse referred to herein is solely my/our horse, and there is/are no other person/s having any share or interest in the horse, and I/we acknowledge that I/we shall relinquish ownership of the horse by my/our signature/s on this document in the event of a successful claim. In such event, this document becomes, and forms part of, the transfer document, as required by Rule 111.

I/we hereby agree to indemnify the Controlling Body and/or any claimant/s against any action which may result from a Transfer of Ownership caused by the said horse being claimed in a race.

HORSE UNDER LEASE *(Optional Clause)*

In the event that the above horse is the subject of an existing lease, the LESSOR agrees to pay to the LESSEE, within twenty-eight (28) days of the horse being claimed, the sum of money equivalent to _____ % (percent) of the gross claiming money received by the LESSOR for the horse.

The LESSEE's signature/s on this form shall operate as a surrender of this lease, in the event of the horse being claimed in a claiming race, upon the registration of any change of ownership arising from a successful claim.
