BROOD MARE LEASE AGREEMENT

REQUIREMENTS / CONDITIONS

- 1) The Brood Mare Lease Agreement MUST be submitted to HRNSW prior to the commencement of the first breeding season to be covered by the agreement (ie: before the first date of service of the mare being leased). Note that Brood Mare Lease Agreements submitted retrospectively (ie: after the commencement of the breeding season) may be declined by HRNSW. Note: The Lease Commencement Date must a minimum of one clear day prior to the date of the first service, with the Lease Finalisation date being at least day after the mare has foaled;
- 2) **Brood Mare Lease Agreements** that are submitted without payment details to cover the required transaction fee will be returned to the LESSEE(s) unprocessed;
- 3) Additional fees that may be associated with the resultant foals (state notification fees, mare DNA testing fees, state series registration fees, etc) are the sole responsibility of the LESSEE(s) unless otherwise agreed between the parties;
- 4) All details on the Brood Mare Lease Agreement must be completed in full, with particular attention being given to the recording of the names and signatures of all applicable OWNERS and LESSEES. Incomplete, incomplete or illegible notifications will be returned to the LESSEE(s) unprocessed, as will agreements submitted without all names and signatures represented;
- 5) **OWNERS** and **LESSEES** ensure that all details associated with this **Brood Mare Lease Agreement** are fully understood and have been agreed to between all parties prior to the agreement being submitted as HRNSW will not resolve any disputes should they arise. If there are any special conditions to be applied to the terms of the lease, record these details in the **SPECIAL CONDITIONS** section above.
- 6) Note that the foal associated with this **Brood Mare Lease Agreement**, once processed by Harness Racing NSW, will be displayed on the national database and HarnessWeb as having been bred by, and being currently owned by, the LESSEE(s).
