LICENCE UPGRADE APPLICATION CHECKLIST

- ☐ I hold a current B Grade Trainer's licence with HRNSW, and have held this licence level for a period of not less than twelve (12) consecutive months;
- ☐ I have undertaken a HRNSW Medical Assessment during the last six (6) calendar months (*see note below*);
- ☐ I have applied for (or already have registered) a Property Identification Code (PIC) for my intended stabling premises.

➤ *If you have not undertaken a HRNSW Medical Assessment during the last six months you may be required to do so as part of the overall licence upgrade process.*

To minimise the overall cycle time for processing your Licence Upgrade Application, please provide responses to the following questions (responses must be detailed in writing and accompany this Licence Upgrade Application form when submitted to HRNSW):

- 1) please provide an indication as to how many additional outside horses you are considering taking on, and the time frame in which such additional horses would be added to your stable;
- 2) specify what owners, if any, you have approached (or whom have approached you) in relation to the taking on of additional outside horses;
- 3) please provide details of the anticipated impact the proposed increase to the number of horses to be trained will have on your current stabling arrangements, and what provisions have you made or will you make to adequately accommodate additional horses.

Note that all Licence Upgrade Applications submitted are subject to review by the Harness Racing NSW Licensing Committee which may necessitate further information and/or undertakings on your part prior to a Licence Upgrade Application being considered or approved.

Further information regarding the documentary and training requirements associated with the licence upgrade you have applied for are contained in the HRNSW Licensing Policy (available at www.hrnsw.com.au or by contacting Harness Racing NSW) full details of which will be made available to the applicant subsequent to receipt and processing of this Licence Upgrade Application.

Please allow between 2 – 6 weeks for the processing of your Licence Upgrade Application (dependent upon lodgement date). Note that Licence Upgrade Applications received during the annual renewal processing period may be held until existing participant licence renewals have been finalised before being considered.
